Conflict Minerals legislation requires affected companies to show due diligence and perform Reasonable Country of Origin Inquiries (RCOIs) to all suppliers of their affected parts.

Using a standard CMRT form, this RCOI data collection step requires companies to contact suppliers throughout their supply chain all the way down to the Smelters or Refiners (SORs) themselves.
