Plus, you'll receive **online updates** of changes to regulations and substance data so that you're always dealing with the most up-to-date information.

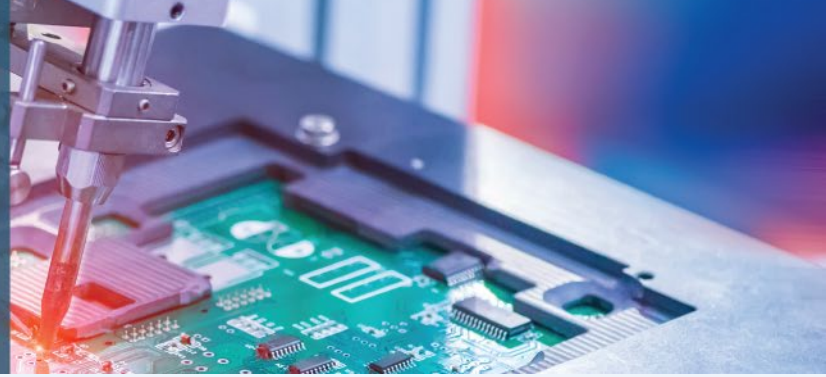
Once substance data is collected from your supply chain and imported into GDM software, you'll be able to perform functions such as:

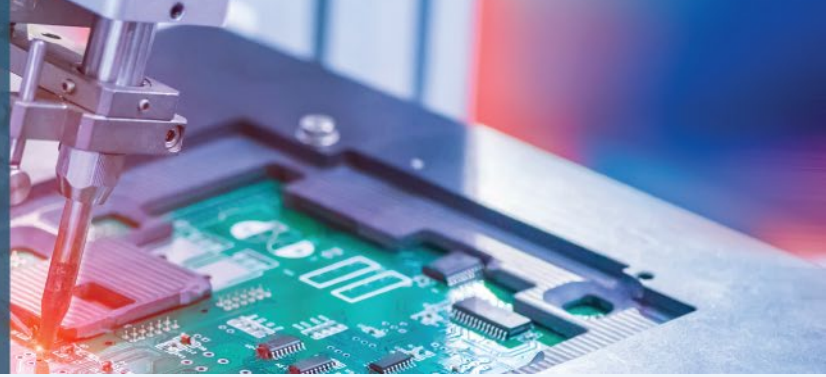
